Thank you for your e-mail regarding a windfarm at ------

While I appreciate your concerns at the impact of the wind farm in relation to noise and flicker, I regret that this is not a matter in which the Scottish Government or the Scottish Ministers can intervene.

As I understand it, the wind farm has planning permission and is now operational. As such the planning permission cannot now be withdrawn or modified.

Where the operation of the wind farm breaches any conditions imposed on it through the planning consent, it would be for the relevant planning authority to consider the matter and if the authority consider that the operations are in breach of conditions, they have a range of enforcement powers at their disposal to mitigate the impact of the breach and resolve the matter. It would be for the planning authority to consider any individual case and to take whatever action they considered appropriate.

Regardless of any conditions, the grant of planning permission does not confer any right to ignore, or remove any responsibility to comply with, other legislation, such as noise and statutory nuisance legislation. Again this would be a matter for the relevant local authority to consider and for the environmental health department of that authority to take action if there was determined to be a breach of environmental legislation.

While I appreciate that this will not be the answer you would have hoped for, I trust it explains the Scottish government position.

First and foremost is the excessive noise generated by these turbines most of the time they have been running. We are all having severe sleep problems and unless it can be remedied very soon we cannot continue living at Farm which I should add has been in the family ownership since the late 1940's and never in my life did I dream that we could possibly be subjected to such horror as could make us consider selling up and moving, which brings me to the point of dramatic de-valuation of our property by this development. reporters were here at but cannot have merited their consideration. The sun most of the winter passes low above the hill directly behind the turbines and at least 10 of these create blade flicker which affects us here at the farm. Lastly the visual impact has to be seen to be believed. The photomontage we were led to believe was genuine looked nothing like the real thing. Finally I should repeat what was told to the reporters that one of our grandchildren living here at has severe Autism and the effect on her is very damaging to herself and causing great distress to her whole family. My daughter who lives on the farm suffers from MS and suffers severe headaches and loss of co-ordination when subjected to prolonged blade flicker We have had discussions with (operator) regarding all the points and they have installed a sound monitor at one of the dwellings and

we are at present trying to find an independent firm who would install same to give a genuine picture.
